- ➔ Covered footwear for river wade

INSTRUCTOR...

- ➔ Pass internal training and assessment program
- ➔ Current first aid certificate

RESTRICTIONS

- Over 10 years old
- No back injuries
- Not suitable for pregnant woman

- 1 Instructor: 10 students
- 1 Instructor + 1 Adult: 15 Students
