Death/Serious Injury (Drowning)	- Inadequate instruction/ supervision - Failure to follow instruction/ inattentiveness	- Instructors are suitably trained - Clear instructions are given - Listen to instructions and remain attentive	TSCC TS Instructor Group Leaders	Before During	<i>Suspected major injury</i> - Instructor to coordinate first aid - Activity stops - Instructor to radio to main office to arrange for ambulance or extra assistance - Assess if activity can continue - Group leader to ensure other group members are cared for
	- Flooded river - Participants unable to swim	- Activity must not take place while river is in flood - Unconfident swimmers shouldn't enter the water without a buoyancy aid - Supervising adult positioned near landing area	TS Instructor Participants + Group leaders	Before Beginning & During	
Impact Injury (Water, surface, river bed, or other person)	- Submerged object, e.g. sticks, debris - Shallow water - Swimmer(s) in landing area - Inappropriate entry to water - Failure to apply instructions given re: slide use, water entry	- Pre-check river for hazards and correct depth - Exit river ASAP, no swimming below slide - Land bottom first- feet and head up - Listen attentively and follow instructions	Group Leader Group Leader Participants + Group leaders	Before During During	<i>Entrapment</i> - Instructor to release trapped item <i>Hypothermia</i> - Remove them from the activity - Arrange for change of dry warm clothes - Have some high-energy food and a warm drink
Entrapment Injury (fingers)	- Equipment – poor condition - Submerged object	- Regular checks by instructors - Pre activity check	TSCC TS Instructor	Monthly Before beginning	- Have some high-energy food and a warm drink
Exposure to Elements (Sun, wind, temperature)	- Long periods out in the sun or wind and rain without correct clothes	- Move to an indoor Activity during "bad weather" - Ensure the group has adequate clothing	TS instructor Participants + Group leaders	Before Before & During	<i>Other/ Minor Injury</i>
Psychological Harm	- Being bullied or forced to participate	- Challenge by choice - Group encouragement	TS instructor Participants + GL	During	- Group leader to administer first aid
