Allergies and irritation	<ul style="list-style-type: none"> - Allergies to soap - Foam in eyes 	<ul style="list-style-type: none"> - Inform group that the foam is made of soap - Have water available to wash eyes 	<p>TS Instructor</p>	<p>Before</p> <p>During</p>	<ul style="list-style-type: none"> - Arrange for change of dry warm clothes - Have some high-energy food and a warm drink
Exposure to elements (sun, wind, temperature)	<ul style="list-style-type: none"> - Long periods out in the sun or wind and rain without correct clothes 	<ul style="list-style-type: none"> - Move to an indoor Activity during "bad weather" - Ensure the group has adequate clothing 	<p>TS instructor</p> <p>Participants + Group leaders</p>	<p>Before</p> <p>Before & During</p>	<p><i>Other/ Minor Injury</i></p> <ul style="list-style-type: none"> - Group leader to administer first aid
