Death/Serious injury (impact from other person, Drowning)	<ul style="list-style-type: none"> <li>- Inadequate instruction</li> <li>- Failure to follow instruction re: procedures and boundaries</li> <li>- Participant unable to lift head out of water</li> </ul>	<ul style="list-style-type: none"> <li>- Instructors are suitably qualified</li> <li>- Clear instructions are given</li> <li>- Listen attentively and follow instructions</li> <li>- Supervising adult positioned near landing area</li> </ul>	<p>TSCC</p> <p>TS instructor</p> <p><b>Group leaders</b></p>	<p>Before</p> <p>Before and during</p> <p>During</p>	<p><i>Suspected major injury</i></p> <ul style="list-style-type: none"> <li>- Instructor to coordinate first aid</li> <li>- Activity stops</li> <li>- Instructor to radio to main office to arrange for ambulance or extra assistance</li> </ul>
Impact Injury (impact from other person or slide, limb caught)	<ul style="list-style-type: none"> <li>- Bystanders in landing area</li> <li>- Failure to apply instructions given re: slide use, exiting slide</li> <li>- Equipment – poor condition, hole in tarp</li> </ul>	<ul style="list-style-type: none"> <li>- Exit slide ASAP</li> <li>- Landing zone must be clear before releasing next slider</li> <li>- Read/Listen attentively and follow instructions</li> <li>- Regular checks by instructor</li> </ul>	<p>Group leaders</p> <p>Participants</p> <p>Participants + Group leaders</p> <p>TS Instructor</p>	<p>During</p> <p>During</p> <p>Before</p>	<ul style="list-style-type: none"> <li>- Assess if activity can continue</li> <li>- Group leader to ensure other group members are cared for</li> </ul>
Bumps, Bruises, Scraps, Strains, Sprains	<ul style="list-style-type: none"> <li>- Poor supervision</li> <li>- Improper use of equipment</li> <li>- Tarp Burn</li> </ul>	<ul style="list-style-type: none"> <li>- Ensure the whole group is listening during briefing</li> <li>- Only trained staff to run activity</li> <li>- Only use with water</li> <li>- Slide down the middle of slide</li> </ul>	<p><b>Participants + Group leaders</b></p> <p><b>TS instructor</b></p> <p><b>Participants</b></p>	<p>Before</p> <p>During</p>	<p><i>Hypothermia</i></p> <ul style="list-style-type: none"> <li>- Remove them from the activity</li> <li>- Arrange for change of dry warm clothes</li> </ul>
Exposure to elements (sun, wind, temperature)	<ul style="list-style-type: none"> <li>- Long periods out in the sun or wind and rain without correct clothes</li> </ul>	<ul style="list-style-type: none"> <li>- Move to an indoor Activity during “bad weather”</li> <li>- Ensure the group has adequate clothing</li> </ul>	<p>TS instructor</p> <p><b>Participants + Group leaders</b></p>	<p>Before</p> <p>Before &amp; During</p>	<ul style="list-style-type: none"> <li>- Have some high-energy food and a warm drink</li> </ul>
Psychological harm	<ul style="list-style-type: none"> <li>- Being bullied or forced to participate</li> </ul>	<ul style="list-style-type: none"> <li>- Challenge by choice</li> <li>- Group encouragement</li> </ul>	<p>TS instructor</p> <p><b>Participants + GL</b></p>	<p>During</p>	<p><i>Other/ Minor Injury</i></p> <ul style="list-style-type: none"> <li>- Group leader to administer first aid</li> </ul>
