	- Hit by train	- No running or biking beside or behind the train	TS Instructor	During	
Bumps, Bruises, Scrapes, Strains, Sprains	- Hand/arms outside the carriage - Pushing to get on train	- Hands must remain inside the carriage at all times - Have a line for who is next on the train.	TS Instructor Group leaders	Before & during	
Entrapment	- Inappropriate clothing - long hair	- Remove loose clothing - tie long hair up and confined	Participants + Group leaders	Before & during	
Exposure to Elements (sun, wind, temperature)	- Long periods out in the sun or wind and rain without correct clothes	- Move to an indoor Activity during "bad weather" - Ensure the group has adequate clothing	TS instructor Participants + Group leaders	Before Before & During	
Equipment Damage (Mule, carriage)	- Track too wet - Turning too sharp - Crash/Accident - Overloaded carriage	- Must not be used in heavy rain - Stick to designated route - Stay in control, drive to your ability - Do not exceed 8kph - Follow weight limits	TS instructor	Before & During	
Psychological Harm	- Being bullied or forced to participate	- Challenge by choice - Group encouragement	TS instructor Participants + GL	During
